**David Fleshler** is the Associate Provost for International Affairs at Case Western Reserve University. Fleshler has extensive international-relations experience. At the Board of Regents, he led the statewide effort to internationalize both public and private universities; he helped establish key centers of excellence, such as the University of Akron's BioInnovation Institute; and he worked to extend resources for commercialization and entrepreneurship. Fleshler was also chief of staff to former U.S. Congressman Eric Fingerhut and spent eight years at the Jewish Community Federation of Cleveland, where he led its international efforts, which included establishing partnerships with organizations in Israel, Hungary, Russia and elsewhere.
