He is currently Chair of the Senior International Officers of the Committee for Institutional Cooperation, and serves on the Boards of the Midwest Universities Consortium for International Activities, the Columbus Council on World Affairs and the Columbus Sister Cities International. Dr. Brustein is the recipient of the 2013 Charles Klasek Award.
