Programs like Optional Practical Training (OPT) and Curricular Practical Training (CPT) allow students to gain valuable work experience in their field of study while in the U.S. SIOs should ensure that international students are aware of these opportunities and the requirements to qualify for them, as they are significant considerations for international students when choosing a country in which to study.

4. CULTURAL INTEGRATION AND SUPPORT SERVICES ARE KEY DRIVERS TO INTERNATIONAL STUDENT SUCCESS AT COMMUNITY COLLEGES
