









U.S. Enrollment of International Students

Places of Origin - International Students 2022/23




New Enrollment & Percentage Change

The UK government offers several scholarship options, such as Warm Welcome, Chevening and others.




Canada has been focused on providing pathways to permanent residency and citizenship.




Australia is focusing on diversification, meeting skills needs, putting students at the centre and growth & global competitiveness.

Opportunities & Challenges to U.S. Dominance in Attracting International Students



U.K. surpasses U.S. in attracting Chinese students



Canadian international student cap will cause 35% decline in approved study permits in 2024



Significant rise in international student numbers in Australia over the past two decades.

The Current Landscape of International Student Enrollment in U.S. Institutions



US Rebounds

U.S. International student enrollment in rebounds, surpassing 1 million students.



Africa takes the Stage

Africa emerges as a major growth area, surpassing Europe at some institutions.



China Declines; India Surges

Internal data shows declining Chinese enrollment (-26% since 2018) but rapidly rising Indian enrollment (+72%).



Students Weigh Options

Students are applying to institutions in up to 4 countries amid increasing competition.

International Students' Decision Factors



Aggressive Recruiting

Australia, UK, and Canada are aggressively recruiting international students.



U.S. Dominance Waning

U.S. dominance faces strong competition as international student enrollment landscape evolves



Simplified Visa Process

Canada simplifies visa process to attract international students, offering pathways to permanent residency.



Employment Barriers

50%+ of prospective students are motivated by post-study employment, but 46% cite visa delays and 38% lack of willing employers as barriers.



Interest in Permanent Residency

International students keen on permanent residency in Canada.



Lack of Career Support Services

Nearly 40% want more career support services to aid job search and retention.



Reputation, job prospects, and quality of programs among top deciding factors in selection




Deciding Factors Under Consideration by International Students

More student support port-graduation is wanted by international students







